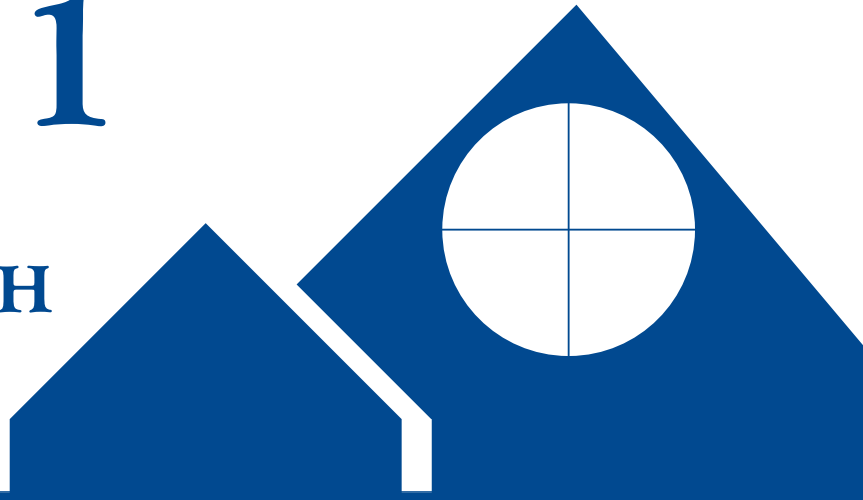


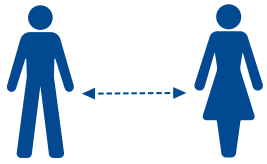
LEVEL 1

COVID-19 COMMUNITY HEALTH

MITIGATION



Temperature: Taken daily at home; 100.4° (+) cannot enter school.

Face masks: Recommended but optional.

Social Distancing: Encouraged in public and passing areas.

Handwashing: Frequent use of hand sanitizer and hand washing.

CLEANING



Daytime: Students and teachers encouraged to sanitize personal work areas throughout the school day.

Nighttime: Thorough cleaning of classrooms and public areas.

VISITORS & RE-ENTRY



Parents/ Visitors/ Vendors: Temperature check and I.D. required at sign-in; face masks recommended but optional; parent access to various areas of campus permitted with social distancing.

Re-Entry: Off-campus student privileges allowed with restrictions.

CO-CURRICULARS



Athletics: Athletic teams operate according to I.H.S.A.A. guidelines; temperature check required by Athletic Director or coach.

After-School Clubs: Student clubs meet with social distancing; face masks recommended but optional.

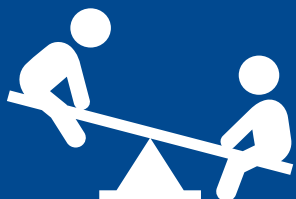
EVENTS



Campus Events: Concerts, plays, and social events will continue with social distancing; face masks recommended but optional.

Assemblies/ Announcements: Students and faculty can assemble with social distancing; face masks recommended but optional.

BEFORE & AFTER CARE



Before Care: Open 7:15-7:40 am (PS only); temperature check required at home; face masks recommended but optional.

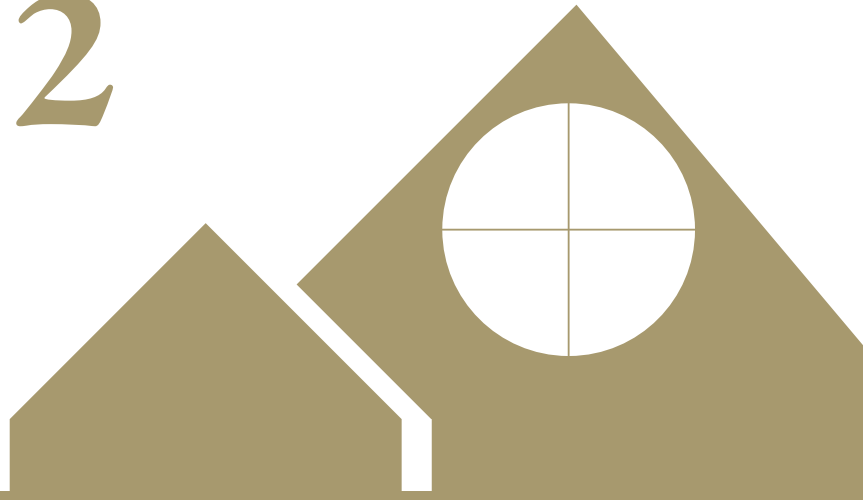
After Care: Open 3-5:30 pm (PS)/ 3-5 pm (MS); face masks recommended but optional.

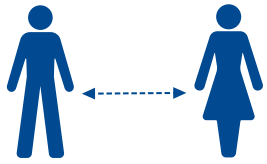

MITIGATION



Temperature: Taken on arrival by EDS staff; 100.4° (+) cannot enter.

CLEANING



Daytime: Students and teachers encouraged to sanitize work areas throughout the day and between classes; maintenance staff will sanitize public areas and bathrooms throughout day.

Nighttime: Thorough cleaning and disinfecting of the entire building.

VISITORS & RE-ENTRY



Parents/ Visitors/ Vendors: Temperature check and I.D. required at sign-in; face masks required; parent access to building restricted to public areas only with social distancing.

Re-Entry: Off-campus student privileges allowed with restrictions.

CO-CURRICULARS



Athletics: Athletic teams operate according to I.H.S.A.A. guidelines; temperature check required by Athletic Director or coach.

After-School Clubs: At coach's discretion, clubs meet with social distancing; face masks strongly recommended.

EVENTS



Campus Events: Concerts, plays, and social events continue with social distancing; face masks required.

Assemblies/ Announcements: Students and faculty can assemble with social distancing; face masks required.

BEFORE & AFTER CARE



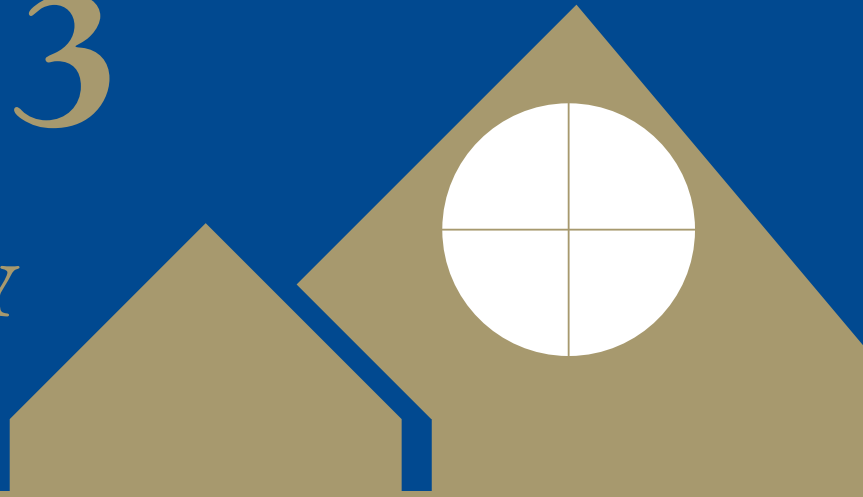
Before Care: Open 7:15-7:40 am (PS only); temperature check and social distancing required; face masks strongly recommended.

After Care: Open 3-5:30 pm (PS)/ 3-5 pm (MS); social distancing required; face masks strongly recommended.

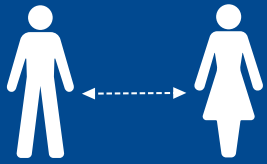
LEVEL 3

COVID-19 ENHANCED SAFETY

MITIGATION



Temperature: Taken on arrival by EDS staff; 100.4° (+) cannot enter.

Face masks: Required at all times while on campus.

Social Distancing: Implemented in all areas where able to comply.

Handwashing: Frequent use of hand sanitizer and hand washing.

CLEANING



Daytime: Students and teachers required to sanitize work areas throughout the school day and between classes; maintenance staff will sanitize public areas and bathrooms throughout the day.

Nighttime: Thorough sanitizing of entire building at night and over the weekends; campus potentially closed for one or more days of remote learning to allow for additional cleaning.

VISITORS & RE-ENTRY



Parents/ Visitors/ Vendors: Emergency-only or by appointment; temperature check and I.D. required at sign-in; face masks required.

Re-Entry: Restricted to medical appointments; students must present doctor's excuse to re-enter campus during school day.

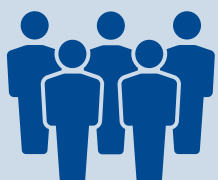
CO-CURRICULARS



Athletics: Athletic teams operate according to I.H.S.A.A. guidelines; temperature check by A.D. or coach; spectators may be limited.

After-School Clubs: At coach's discretion, clubs meet with social distancing; face masks required.

EVENTS



Campus Events: Concerts, plays, and social events canceled or conducted remotely.

Assemblies/ Announcements: All in-school assemblies canceled.

BEFORE & AFTER CARE



Before Care: Open 7:15-7:40 am (PS only); temperature check required; social distancing implemented; face masks required.

After Care: Open 3-5:30 pm (PS)/ 3-5 pm (MS); social distancing implemented; face masks required.

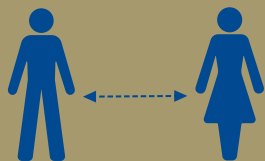
LEVEL 4

COVID-19 REMOTE LEARNING

In case of partial closures (by grade or by division), in-person learning will follow Level 3 protocols.

MITIGATION



Closures: Remote learning will be in place for partial closures (by grade or by division) and all-school closures.

In case of partial closures (by grade or by division), in-person learning will follow Level 3 protocols.

CLEANING



Partial Closures: Additional cleaning and sanitizing of impacted division(s), classrooms, and all public areas.

All-School Closures: Additional cleaning and sanitizing of school facilities and grounds; maintenance staff will sanitize building on a daily basis for employee safety.

FACILITIES



Facilities: In case of all-school closure, indoor and outdoor facilities will be closed to non-employees. For partial closures, access will be allowed in open divisions with Level 3 protocols in place.

Parents/ Visitors/ Vendors: All non-employees must make appointment to enter campus; temperature check and I.D. required at sign-in; face masks required at all times.

CO-CURRICULARS



Athletics: At the school's discretion, teams may operate according to I.H.S.A.A. recommendations, or cancel events as needed.

After-School Clubs: Clubs and activities canceled or conducted remotely.

EVENTS



Campus Events: Events canceled or conducted remotely.

SUPPORT



Continuity: EDS faculty and administrators are committed to continuing instruction on digital platforms during partial and all-school closures, as well as provide one-on-one academic support.

SEL: Social and Emotional Learning counseling is available for students and parents needing extra support.

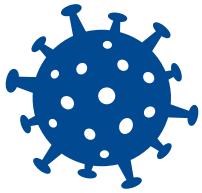

MEDICAL POLICIES

Evansville Day School's medical policies were developed by the school administration and nurse, using resources from the Indiana Department of Education and Center for Disease Control guidelines.

SYMPTOMS



People with COVID-19 have a range of symptoms which may appear 2-14 days after exposure. The CDC list of symptoms include:

Fever of 100.4° (+), chills, cough, shortness of breath or difficulty breathing, fatigue, muscle pain, headache, sore throat, loss of taste or smell, congestion or runny nose, nausea or vomiting, and diarrhea.

FEVER POLICY



Students are required to check their temperature daily before coming to school. Temperatures of 100.4° (+) must stay home.

EDS staff will check temperatures at drop-off in Levels 2-3 protocols.

Students must be fever-free for a minimum of 72 hours without the use of acetaminophen or ibuprofen before returning to school.

DISMISSAL



Students with 100.4° (+) will be immediately sent home from school.

Students exhibiting one or more COVID-19 symptoms but no fever will be immediately isolated on campus. The nurse will contact parent(s) for consultation but will have final authority whether or not to send a fever-free student home from school.

SAFE RETURN



Students who have NOT been tested for COVID-19 may return to school when ALL criteria are met:

1. Have been fever-free for 72 hours without the use of acetaminophen or ibuprofen;
2. Physician clears student to return (e.g. non-COVID-19 diagnosis), OR at least ten days have passed since symptoms first appeared.

Students who test POSITIVE for COVID-19 may return to school when ALL criteria are met:

1. Have been fever-free for 72 hours without the use of acetaminophen or ibuprofen;
2. Physician clears student to return;
3. At least ten days have passed since symptoms first appeared;
4. Can document two negative tests taken at least 24 hours apart.

Students who test NEGATIVE for COVID-19 but displayed symptoms may return to school when ALL criteria are met:

1. Have been fever-free for 72 hours without the use of acetaminophen or ibuprofen;
2. Can document negative test;
3. Physician clears student to return.
